- 1.2 TOML [hereinafter "We"] is a collective of visual storytellers, who are collaborate to produce visual communication projects [hereinafter "Services"]
- 1.3 Our internal insights, expertise and previous collaborating experience with each other allows us to build the right teams or select the right type of artists, for the right project.
- 1.4 The Consultants of TOML [hereinafter "Artists"] are legally represented by TOML.

### 2. WE MAKE VISUAL STORIES

#### Request a creative solution

We build the right team or assign the right artist(s) for a project.

2.1. Clients requests creative services or project-based collaboration with TOML.

2.2. We collaborate with our own clients and also work as a creative partner for other creative agencies and production houses.

2.3. TOML selects the most suitable artists to fit the right project.

2.4. The selection is influenced by the brief style, experiences, artist's preferences and budget.

2.5. The selected team is always transparent, and clients can suggest an Artist to work with.

### 3. WE REPRESENT ARTISTS

#### Invite an Artist

Invite an artist to involve in your project.

3.1 TOML legally represents Artists who are listed in our website as "Members".

3.2 Clients can invite **one** of the Artists to involve in their own creative project. The brief should be sent through be TOML's website via "Invite an Artist" button or via email. We will review the request and check artist's availability.

3.2 TOML connects and manage the link between Artist and the Client, and takes care of the admin work for 25% fee of the total agreement (unless agreed differently).

## 4. INTELLECTUAL PROPERTY RIGHTS

---

4.1 TOML is the owner of intellectual property rights for the work and content that is displayed as TOML copyright [Projects] within the homepage of the website, whereas all the work and content that is presented in the Artists portfolio is under the copyright of the Artists or third parties (hover with mouse to see the credits).

4.2 TOML respects all the creators and agencies who participated or developed a project. However, we have no proprietary rights over the work and content presented by the Artists and shall not be liable to any third party with regard to any copyright claim towards the content the Artists agreed to publish. If for some reason, a creative agency prefers not display their work via our website, please write us an email (the Artist must be included in CC).

4.3 You are not allowed to acquire any right, title nor interest in any intellectual property rights belonging to TOML or to the Artist. You may not copy, modify, distribute, sell, or lease work or content published in our website, unless you have our [or Artist's] written permission.

## 5. PRIVACY & TERMS OF USE

### What Types of User Information Does TOML obtain?

TOML may hold all the personal data about you that we receive, including personal details such as your name, e-mail address, work title, and other information provided by you voluntarily. These will not be shared with any third-party except the team who are involved in the project. These information may be collected only if you submit a creative brief via our website section such as:
